Instructions for Reporting to the Institute for Counselling Round and Admission Process:

- 1. **Counselling Round (Spot Round):** Candidates are required to report for the counselling round on Monday, 9th September 2024, at 2 PM. Please bring your Aadhar Card for verification; failure to do so will result in being denied entry to the Hall.
- 2. Merit Information: Candidates must have details of their AI Merit Number and State General Merit Number, which can be downloaded from the following MahaCET link: <u>https://mba2024.mahacet.org.in/cetmba24/mba24/index.php/MeritListController/final</u> <u>Merit</u>
- 3. Admission Based on Merit: Admission will be conducted based on merit and categoryspecific vacancies. Candidates who have applied and are physically present will be considered. MHCET CELL/DTE rules will be followed for seat allotment.
- 4. **State Merit Number:** Admission will be based on State Merit Number. Candidates should have their Application ID and Password ready for verification.
- 5. Admission Confirmation: Selected candidates must confirm their admission immediately by submitting all required original documents and paying the Full Fees (i.e. Rs. 1,47,000/-)
- 6. **Required Documents:** Candidates should bring the following original documents and two sets of photocopies for verification:
 - Online application form submitted for CAP participation.
 - FC/E-scrutiny verification letter.
 - CET Scorecard.
 - SSC (Std. X) mark sheet and certificate.
 - HSC/Diploma mark sheet and certificate.
 - Qualifying Examination mark sheet.
 - Degree certificate.
 - Transfer Certificate/College Leaving Certificate.
 - Migration Certificate.
 - Proof of Indian Nationality.

- 9. Second Counselling Round: In the event of any cancellations, a second counselling round will be held on 11th September 2024 at 11AM for remaining candidates, who must be physically present.
- 10. **Scholarship/ Free-ship:** Students admitted through this round will not be eligible for any government scholarship or free-ship scheme.
