Point No. 1: To discuss schedule about AQAR 2019-20 and 20-21.

Preamble: As a norm the Annual Quality Assurance Report (AQAR) laid down by NAAC has to be uploaded on or before 31/12/2021. The date for the uploading of 2019-20, 2020-21has been extended to 31/12/2021. It is mandatory to upload the AQAR

Resolution: It is resolved that the AQAR 2019-20 will be uploaded on the 30th November 2021 and AQAR 20-21 will be uploaded on the 20th December 2021 by the IQAC Co-ordinator Dr. Anuradha D.

Point No. 2: To discuss timings of meetings, notices from Administrative staff as a quality policy.

Preamble: The Institute has 25 committees, which has different convenors and committee members. Meetings for each committee is mandatory and the minutes, notices are to be conveyed to the Director & committee members in advance. Also, the administrative staff at the Institute issues notices pertaining to the academic, administrative details, holidays through official mails

Resolution: It is resolved that the Institute will be following the announcement of any meeting in advance that is at least a day before to all members. The Convenor should get the points for discussion prior to the meeting. The Director's gave directions that all notices academic & administrative holidays will be declared 1-2 days earlier. This will be the quality policy henceforth.

It can host corporate events, guest lectures, and workshops to foster connections.) 2) Alumni Network: The institute can formally establish an Alumni Cell, the institute can leverage a strong alumni network. 3) Corporate Engagement: The institute can regularly invite industry leaders to interact with students through guest lectures or conferences.
