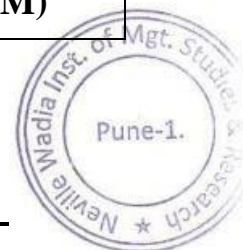

Instructions for Reporting to the Institute for Counselling Round and Admission Process:

- Counselling Round (Spot Round):** Candidates are required to report for the counselling round on Wednesday, 11th September 2025, at 10.00 AM. Please bring your Aadhar Card for verification; failure to do so will result in being denied entry to the Hall.
- Merit Information:** Candidates must have details of their AI Merit Number and State General Merit Number, which can be downloaded from the following MahaCET link: https://mba2025.mahacet.org.in/cetmba25/mba25/staticFiles/mba/mba_final_merit_mh_2025_26.pdf
- Admission Based on Merit:** Admission will be conducted based on merit and category-specific vacancies. Candidates who have applied and are physically present will be considered. MHCET CELL/DTE rules will be followed for seat allotment.
- State Merit Number:** Admission will be based on State Merit Number. Candidates should have their Application ID and Password ready for verification.
- Admission Confirmation:** Selected candidates must confirm their admission immediately by submitting all required original documents and **paying the Full Fees (i.e. Rs. 1,34,000/-)**
- Required Documents:** Candidates should bring the following original documents and two sets of photocopies for verification:
 - Online application form submitted for CAP participation.
 - FC/E-scrutiny verification letter.
 - CET Scorecard.
 - SSC (Std. X) mark sheet and certificate.
 - HSC/Diploma mark sheet and certificate.
 - Qualifying Examination mark sheet.
 - Degree certificate.
 - Transfer Certificate/College Leaving Certificate.
 - Migration Certificate.
 - GAP Certificate
 - Proof of Indian Nationality.

Additional Documents for Reserved Category Candidates:

- Caste certificate.
- Caste validity certificate.
- Non-creamy layer certificate (valid until 31st March 2025).
- Any other applicable documents.
